	 Confirmation of Application: **Upon Submission of your application form, applicants will be provided a unique Application Reference Number and an Acknowledgement Letter that carries the file number for the application by the Ministry of Commerce, Industry, and Cooperatives & Tourism located at 2nd Floor Gwadangwaji Secretariat Complex Birnin Kebbi. Processing Timeline Submitted applications for business premises permits will be processed within 24 hours prior to the final stage for collection described in step 4 below.

	• Successful applicants for BPP will be notified via text, call or email within 48 hours .		
	• Within 48 hours upon making all relevant payments the applicant will be notified of successful processing and can visit Ministry of Commerce, Industry, Cooperatives & Tourism located at 2 nd Floor Gwadangwaji Secretariat Complex Birnin Kebbi) OR		
	• Visit any Zonal Offices located at: Argungu, Yauri, Zuru or in Birnin Kebbi in location(s) indicated in Step 3 above.
