<u>APPROPRIATION LAW FOR THE PERIOD BEGINNING</u> <u>JANUARY – DECEMBER, 2020</u>

BE IT ENACTED BY THE KEBBI STATE HOUSE OF ASSEMBLY as follows: -

Citation and commencement.

1. This Law may be cited as the Appropriation Law, 2020 and shall come into force on the.....day of.....2020.

Financial Year

2. The appropriation made under this Law shall be for the *financial year* beginning on the 1st day of January, 2020 and ending on the 31st day of December, 2020.

Authorized expenditure.

3. The Accountant General of Kebbi State may on a Warrant signed by the Commissioner of Finance, issue from the Consolidated Revenue Fund of Kebbi State during the financial year beginning from 1st day of January, 2020 and ending 31st day of December, 2020, a sum not exceeding in the whole the sum of One Hundred and Thirty-Eight Billion, One Hundred and Thirty-Five Million, Eight Hundred and Thirty-One Thousand, Seven Hundred and Five Naira only, being the total of the amount set forth opposite the Heads specified in the Schedules hereto.

Appropriation of 138,135,831,705

4. The sum of One Hundred and Thirty-Eight Billion, One Hundred and Thirty-Five Million, Eight Hundred and Thirty-One Thousand, Seven Hundred and Five Naira only is hereby appropriated for the purposes of the expenditure set forth opposite the respective Heads specified in the Schedules hereto.
