CITIZENS BUDGET

A Citizen Budget is a simpler, less technical version of a Government's Budget specifically designed to present key information that is understandable by the general Public.

The objective of a citizen Budget is to present State Budgetary information in a manner that is easily digestible for Citizen and is meant to facilitate engagement with their Government for improved service delivery and society development.

The Citizen Budget is to enhanced Budget Openness and Transparency by shedding more light on how the State Government is using the Budget as a tool to manage the State's financial resources.

The 2019 Budget is formulated on the need to consolidate on the gains of the previous years and to upscale infrastructure development of the state for increased social and economic activities for the citizens.

CITIZENS BUDGET

The 2019 Budget is tagged "Budget of Consolidation" to reflect the determination of the Government to strengthen the Internally Generated Revenue {IGR} Mechanism through increased revenue collection in order to ensure payment of Personnel and Overhead costs as well as increased implementation infrastructure development projects for sustainable economic growth and development of the State.

BUDGET SIZE

The 2019 Total Budget size stands at N151,462,236,238.00 consisting of Recurrent and Capital Budget estimated at N47,077,186,420.00 and N104,385,049,818.00 respectively.

Expenditure shows how the money collected by the government will be spent in order to cater for the needs of the people. The expenditure pattern is divided into two parts. One part is called Recurrent Expenditure {i.e day-to-day running of government such as payment of salaries of government workers, payment of debts and daily running of MDAs}. While other part is called Capital expenditure {i.e the future plans expenditure on capital projects such as building of schools, Roads, Markets, Hospitals etc}
